2. Approve Agenda.

- 4. Minutes.
 - 4.1. <u>Motion by Commissioner Taylor, second by Commissioner Beisecker to approve the April 28, 2022</u> <u>minutes. Motion carried unanimously.</u> (Attachment A).

- 5. General Manager's Report.
 - 5.1. Update of Projects & Recent Events.
 - **5.1.A.** The Southeast Water Main Replacement Project is approximately 96% complete. All lines and services are installed. Hydrostatic testing is 40% complete. Coast Chlorinator will begin line disinfection on or about June 1, 2022.
 - **5.1.B.** On May 26, 2022, a progress meeting was held for the Elevated Water Tank Project. A 12" waterline is installed, and tie-in has been made. On June 8, 2022, pile-driving equipment will be mobilized. On June 10, 2022, four pilings for the pile load test are scheduled to be delivered. On June 13, 2022, the remaining 62 pilings are scheduled to be delivered. Pile-driving is anticipated to take two weeks.
 - **5.1.C.** The Notice to Proceed for the Water System Improvement Project Phase II is expected to be issued on June 1, 2022.
 - **5.1.D.** Bid documents are complete on the Water Tower #1 Exterior Painting II Project. Advertising is expected to commence on June 5, 2022, and bid opening is scheduled to take place at the July 14, 2022 board meeting.
 - **5.1.E.** All submittals have been received and reviewed for the Water System Improvement Project Phase III. The project is scheduled to begin in August.

- **5.1.F.** The Sanitary Sewer System Hydraulic Model preliminary final report is complete. Design storm results and projected growth flows have been mapped.
- **5.1.G.** On May 23, 2022, a Notice to Proceed was issued for the Sewer Improvements Basin 13, 16, 17 Project. CCTV crews are scheduled to begin work on June 6, 2022. Materials are arriving and stored on the contractor's laydown yard.
- **5.1.H.** An Abandonment of Utility Easement request has been received 9542 Laa La Place, Phase 2, Unit 4A, Block 11, between Lots 7 & 53. After review of the request, it has been determined that the easement provides no current or future use to the District and abandonment is recommended.
- **5.1.l.** The District has installed 7 new residential water & sewer connections, 1 new sewer cleanout, set 5 cleanout castings, performed 3 water service repairs, 2 sewer service backups, and 3 sewer manhole repairs since the last Board Meeting.
- **5.1.J** Construction drawings were provided by City Manager, Mike Reso, and the City's engineer, for the East Aloha Improvements Project. Drawings were reviewed and revisions recommended in order for the proposed project to be in compliance with DWSD specifications.
- **5.1.K** The temporary emergency pipe supports and culvert installed by the District at the Kolo Court drainage ditch are holding. The temporary measures are an attempt to prevent sewer main damage from an eroding ditch bank while waiting for the City of Diamondhead to develop a drainage plan for the area.
