DIAMONDHEAD WATER AND SEWER DISTRICT REGULAR BOARD MEETING MINUTES

November 17, 2022 - 4:00pm (CST)

Diamondhead City Hall - Council Chambers, 5000 Diamondhead Circle, Diamondhead, MS

1. PRESENT BOARD MEMBERS: Chairman Bryon Griffith, Vice-Chairman Ben Taylor, Treasurer Louis Ertel (by phone), and Commissioner Mark Beisecker (by phone).

ABSENT: Commissioner Arlen Griffey.

The presence of a quorum was noted, and the meeting was called to order at 4:03pm. The public was duly notified in compliance with the District's open meeting policy.

2. Approve Agenda.

Motion by Commissioner Ertel, second by Commissioner Beisecker to approve the agenda. Motion carried unanimously.

3. Public Comments.

Amanda Acker Armstrong, resident at 11524 Haleiwa Place, addressed the Board to request the name "Diamondhead" be placed on the Golf Club Drive (North/South) directions of the existing tower during current repainting project.

- 4. Minutes.
 - 4.1. <u>Motion by Commissioner Beisecker, second by Commissioner Taylor to approve the minutes for the Regular Meeting held on October 27, 2022. Motion carried unanimously. (Attachment A).</u>
- 5. General Manager's Report.
 - 5.1. Update of Recent Events & Projects.
 - **5.1.A.** The lower ball has been raised and is being welded in place for the Elevated Water Tank Project. Raising of the upper ball sections and roof are scheduled to be complete in December 2022.
 - **5.1.B.** Boring on Koloa Street is scheduled to be complete on November 21, 2022 for the Water System Improvement Phase II Project. Boring on Pahoa Court will begin the week of November 21, 2022. The line tie-ins on Bayou Drive are scheduled to start in December.
 - **5.1.C.** The final top coat of paint is 90%-95% complete for the Water Tower #1 Exterior Painting Project. The template for the logo has been set and marked on both sides of the tank and the contractor began painting the logos on November 16, 2022.
 - **5.1.D.** The Water System Improvement Phase III Project is approximately 20% complete: Direct bury is 90% complete and directional drilling is complete. Work is expected to resume after Thanksgiving.

- **5.1.E.** CCTV of the sewer lateral service lines is approximately 35% complete for the Sewer Improvements Basins 13, 16, & 17 Project. Manhole linings are complete. The contractor will be replacing force mains concurrently with gravity sewer lines to the Diamondhead Drive East intersection.
- **5.1.F.** After review of the abandonment of easement request on the property located on Akikai Drive, Phase 1, Unit 2, Block 10, between Lots 11 & 12. It was determined that this easement is of no use to the District at this time or in the future; therefore, approval of Abandonment of Easement is recommended.
- **5.1.G.** The District has performed 4 water service repairs, 1 after hours leak investigation, 2 sewer service backups, 1 sewer line repair, 2 manhole castings/covers have been replaced, and 5 installed new residential water/sewer connections since the last meeting.
- **5.1.H.** The temporary emergency pipe support and culvert installed by the District at the Kolo Court drainage ditch are holding steady and the culvert is working. The temporary measures are an attempt to prevent further sewer main damage from an eroding ditch bank collapse. There has been no response from the City since the drawings were sent from Pickering Engineering on August 4, 2022.
- **5.1.I.** A meeting was held on November 17, 2022 with Pickering Engineering, contractors, and the City Manager to discuss water & sewer infrastructure impacts and planning of water main interruption for relocation of pipeline.
